

2023 MagNut News for the Week – 9<sup>th</sup> Edition – October 31st

Hello Troop MagNut Chairs,

We are in the final weeks of the Fall Product Program, and we want to thank you for taking on these responsibilities. The next couple of weeks will be a busy time for the MagNut program. Here is your MagNut News for the Week – your e-newsletter for updates, reminders, and information during the 2023 Fall Product Program.

**1. Last Week of Online Sales.** This is a last week for Care to Share, magazine, Bark Box, Tervis Tumblers and direct-ship nuts and candy sales. Girl Scout's online storefronts will close on Sunday, November 5<sup>th</sup> at 9:59 pm. If Girl Scouts are short of reaching their goals or are one or two items away from the next reward level, remind them of the Care to Share option. They can ask their customers to consider donating a candy/nut item to your troop's Hometown Hero organization. Care to Share products will be provided to troops in December. **2. Candy and Nut Pick-Up/Delivery.** For those in an Albuquerque, Rio Rancho, Valencia County, East Mountain, and Santa Fe Service Units, your Service Unit MagNut Chair will be contacting you in the coming days about picking up your troop's candy and nut products. Please be on the lookout for communication from them about pick-up times. We're still waiting to confirm delivery dates but anticipate delivery the week of November 6<sup>th</sup>. For those troops in the regional areas expecting candy and nut products from direct shipping, keep an eye on your email for further communications. We expect product to begin shipping as early as this week and into next week.

**3. Receipt sheets and Money Envelopes.** Don't forget you can pick-up receipt sheets and money envelopes from the council office or your local volunteer. We recommend using delivery tickets when families pick up product and receipt sheets to collect money from your Girl Scouts. You can [print receipt sheets from the website](#) or from the file attached to this email. We also have carbon sheets available. Speak with your Service Unit chair (or Council) for carbon receipt sheets.

**4. Only Parents on Product Permission Forms Sign for Product:** Don't forget only the parent that completed the Product Permission Form should be picking up product. The parent listed on the Google Product Permission Form list is the one that completed the form. If a someone else needs to pick up the Girl Scout's order, they can still submit a form. The form doesn't need to be approved before the caregiver can sign for the product, just be sure to confirm they have received a confirmation email from Google. Also, make sure to get a signature for all product picked-up. This makes the parent financially responsible for all the product received. Please count and double count with families as well.

**5. Starting Monday, November 6<sup>th</sup> please remind your families to submit their Girl Scout's rewards.** Rewards will be due by Thursday, November 9<sup>th</sup>. Feel free to share this video with your families so they can select rewards: <https://youtu.be/N-SVZgNPZSE>. Please remember Service Unit Chairs are unable to submit rewards for a troop, so families and troop chairs must submit rewards. If your troop participated in a MagNut Mania Rally, please make sure you have submitted the reflection form here: [MagNut Rally Reflection Form](#) to receive your patches. The deadline to submit the form is Tuesday, November 7<sup>th</sup> at midnight.

If you have any questions or need assistance with product pick-up and distribution or rewards selections, please reach out to your Service Unit MagNut Chair or the Council office. We are more than happy to walk you through the process. Thank you in advance for all the time and energy you will be giving to the Girl Scouts in your troop in the coming days.
