- I understand that all products are to be promptly delivered to customers and monies owed by my family to be paid in full no later than the established deadline of the Troop.
- I will sign and keep a copy of receipts for all product I receive and/or money that I pay the troop leader for product.**
- I understand that all past-due accounts I have will be sent to a collection agency by the Council at the conclusion of the sale.
- I understand that I am responsible for any monies owed to council; I am not, however responsible for any insufficient checks.
- I understand that all monetary proceeds belong to the Council and Troop and are not to be retained by individual girls as their property (Safety Wise Standard 28).
- I understand that due to the rising cost of recovering money from "bad" checks, I will do my best to obtain and write the customer's drivers license and home telephone number on each check I receive.
- I understand that if my daughter participates in the MagNut or Cookie Sale, I cannot have any outstanding debts with the Council.
- I have received a copy of the GS Internet Safety Pledge. By signing this form, I am agreeing to discuss this pledge with my daughter and will ensure she understands and will comply with all aspects of this pledge.
