

Girl Scouts of New Mexico Trails Win Cookies for a Year

OFFICIAL RULES

1. Eligibility: Win Cookies for a Year (the "Sweepstakes") is only open to legal residents of New Mexico and is void where prohibited by law. Employees of Girl Scouts of New Mexico Trails (the "Sponsor") their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited.

2. Agreement to Rules: By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of Girl Scouts of New Mexico Trails as final and binding as it relates to the content. 3. Sweepstakes Period: Entries will be accepted starting on or about February 11, 2019 and ending March 31, 2019. All entries must be received by March 31, 2019 11:59PM EST.

4. How to Enter: The Sweepstakes must be entered by submitting a minimum of two photographs on one post to either Instagram or Twitter. One photo must show the Girl Scouts of New Mexico Trails ABQ Ride Bus Ad and one photo must show a case (12 boxes) of Girl Scout Cookies. Both photos must be photos taken by The Sweepstakes participant and may not be duplicated for additional entries. Entries must include the hashtag #nmgscookies and have two friends tagged in the post. Entries must be made on a public profile for Girl Scouts of New Mexico Trails to receive the entry. You must also follow us on Instagram and/or Twitter. The entry must fulfill all sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Girl Scouts of New Mexico Trails. You may enter multiple times on either social media platform but must not reuse previously submitted photos and you must fill in the information requested. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of Girl Scouts of New Mexico Trails.

5. Prizes: Winners will receive list prizes/approximate retail value. Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by the Sponsor. No cash or other prize substitution permitted except at Sponsor's discretion. The prize is non transferable. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 72 hours from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner selected.
