Leadership Report: Becky Teague, Chair	Becky Teague, Board Chair
Peggy Sanchez Mills, CEO	Today, I have completed my second year as the Chair of this great organization. I am honored to serve you and pleased with the progress we continue to make.
	I have great news! We do not need to make any bylaws amendments this year! Remember last year- we all did some tremendous work and we are a stronger organization for accomplishing that heavy lifting but we certainly don't need to do it again for a few years at least.
	I had the pleasure of attending my first National Convention along with Peggy Sanchez Mills, Beth Barringer, Sonia DeGuzman and thousands of others. It was invigorating, challenging, and at times I felt like we held the future of Girl Scouts in the palm of our hands. Other times it was tedious and tiring as we plowed through the GSUSA bylaws. It is wonderful to be part of a Federated organization that is characterized by shared values, and aligned around common goals. There is definitely power in girls and power in a girl-only environment. I appreciated the opportunity to participate in the Convention!
	While our council is very strong, as you will see from our 2017 Annual Report, we continue to implement our Strategic Vision for our continued growth.
	<ul> <li>As compared to other councils:</li> <li>We were high performing in board engagement;</li> <li>We increased our membership growth and were honored for our success at the Convention. There were only 65 of the 112 councils that had such an increase.</li> <li>We continue to retain over 65% of our girls, in large part because of you who are the leaders. You are that caring, consistent adult who commits endless hours to helping girls become the best they can be and you are providing them with tremendous opportunities for skill building through our badges and experiences in science, technology, engineering and mathematics (STEM), outdoor programming, and healthy lifestyle opportunities. Soon you will see more programming in entrepreneurialism.</li> </ul>

- And thank you for encouraging and supporting the girls to seek their Gold Award such a prestigious award demonstrating their hard work.
- Last year I stood before you and shared that our reserves were low but I am very pleased, as an accountant, to stand before you today and tell you our strategic plan to strengthen our financial position has paid off. Our treasurer will share the details later in the meeting.
- Our fund development efforts also paid off with new grants from Walmart; PNM, where I work, Century Bank; Angel Fire Community Foundation, Angel Fire Rotary, Enterprise Holdings, Intel, Kirtland Spouse's Club Realty Restoration, Sandia National Laboratory, Taos Community Foundation, Los Alamos National Laboratories, and United Ways of Eastern New Mexico and San Juan County. Thank you to all these groups for your financial support for girls. Collectively, last year our team raised over \$326,000.
- Our board of directors is amazing! They provide endless time and talent to this organization as volunteers. I thank them for their commitment and I am proud to be their Chair. And of course, our staff works hard to carry out the mission of girls.
- We all were surprised to hear Boy Scouts will be registering girls into Cub Scouts next year but after the initial surprise, we have found it has provided an excellent opportunity for us to share a few key points. Girls are our number one priority. They never had to be allowed into Girl Scouts; this is their organization, led by them. We have had no discussion about voting boys into our organization. There is a high probability that a successful woman was a Girl Scout and we know that 50% of female business leaders were Girl Scouts; 80% of our female technology leaders were; and 76% of the United States senators who are female were Girl Scouts and 100% of female United States Secretaries of State were Girl Scouts.
- We know we make an impact on girls' futures and our attention will not focus on anything but assuring we continue to make girls number one!
- What I try to do when confronted by a naysayer is to ask how long ago it was that they saw a troop in action, and attended a troop meeting and I also ask where their Girl Scout experience was. I do this because so many naysayers were involved in Girl Scouts five plus years ago, in some other state, and had a really bad experience and they have not realigned their opinion since or been exposed to today's Girl Scouts. So now is the time, we strut our successes and

- do not work against ourselves by sharing our frustrations. Significant concerns, absolutely! But we are the Girl Scouts and we must all defend the organization we love, in spite of our shortcomings. It is in our power together that we strengthen this organization.
- Of course, there will be girls whose needs we are not meeting and that is okay. If a girl wants to be part of a boy only organization, work on the Eagle Scout, participate in primitive camping at Philmont, that should not reflect as a failure for us but it should remind the world that Girl Scouts and Boy Scouts are two very different organizations and cannot be compared to one another anymore than comparing Whole Foods to Albertsons. We simply are different and serve very different populations.
- For us we shouldn't be worried about competitors as much as be focused on meeting the needs of girls who are members or want to be members of Girl Scouts.
- And finally, in the state of New Mexico we have 9,970 members compared to 5,800 members in Boy Scouts. The numbers speak for themselves.

So, I close by thanking you once again for what you do and ask you to help find more caring adults to help the girls who are waiting to participate in a Girl Scout Leadership Experience. Thank you!

You have made a real difference in the lives of the Girl Scouts in Troop 10471 and it means the world to us! The council's fiscal year ended on September 30, 2017. The board **Treasurer's report:** selected Atkinson & Company as our auditors last year and they Molly Emkes, conducted the audit for period ending September 2016, posted on Treasurer our website. The audit for the most recent year will begin early

	December and be presented to the Board in January 2018.
	The unaudited financials for the year are detailed on page 18 of the Council's 2017 annual report. The total revenue for the Council is \$3,501,902, up \$748,545 from last year; with total expenses of \$2,684,521, down by \$14,503 from last year.  Our financials for the year show total assets of \$4,037,517, up by \$325,371 from last year. Liabilities are \$961,517, up from last year by \$165,276. Current assets are \$333,478 and investments are \$1,296968. We experienced a shortfall in cookie revenue. We invested contributions raised into the properties as these are our most important financial assets that we have a fiduciary responsibility to care for and maintain. We always hope for a strong return on our fund development efforts and increasing new revenue sources each year. We remain diligent and conservative in managing our assets and plan for the future with the same.
