## **Getting Your Juliette Started in the 2021 Fall Product Program**

Here are the steps for getting your Juliette started in the GSNMT MagNut Program. MagNut is our council's simple way of say Magazines and Nuts and those are the items Girl Scouts sell during the Fall Product Program along with candy.

### **Step 1: Complete the 2021 Juliette Fall Product Program Caregiver Agreement:**

One caregiver of a Juliette needs to complete their Juliette Fall Product Program Caregiver Agreement form online at:

This lets us know who the primary adult responsible for the family's Fall Product Program will be.

### **Step 2: Complete the 2021-2022 GSNMT Product Permission form:**

One caregiver of a Juliette needs to complete the 2021-2022 Product Program Girl Permission and Parent/Guardian Responsibility form:

### **Step 5: Check Email**

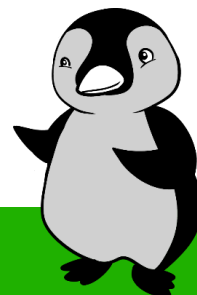
The next business day after completing the certification form, you will receive an email from GSNMT regarding picking-up materials, next steps, and Juliette specific information.

### **Step 6: Attend a MagNut Q&A Session**

If you have questions after watching the trainings or need additional assistance, you can attend a virtual Juliette MagNut Q&A Session with the GSNMT Product Program Manager on Zoom. Dates for sessions will be provided in the training and follow-up email. The session is optional but highly recommended.

#### **Important Dates**

- **September 14<sup>th</sup>:** Deadline to watch trainings and to submit forms to ensure Juliette can participate on 1<sup>st</sup> day of program
- **September 24<sup>th</sup>:** Program begins – online ordering opens and girls may take orders in-person
- **October 17<sup>th</sup>:** Last day to take orders on the paper order card
- **October 21<sup>st</sup>:** Last day for online girl delivery orders
- **November 7<sup>th</sup>:** Last day for online orders for magazines and shipped nut and chocolate orders
- **Week of November 8<sup>th</sup>:** Nut and chocolate items will be delivered to Service Unit sites
