Smart Cookie Reminders

How to Input Cookie Share Orders

A comprehensive video guide on Cookie Share will be made available Friday, March 8th. A troop volunteer must credit the Girl Scouts with the packages. To do this, use the "Tracked Cookie Share"(troop packages) or "Virtual Cookie Share"(council packages) options in the "Orders" drop down. You will need to use Digital Cookie to find out how many packages should be credited to the Girl Scouts. Download the "All Order Data" report at the bottom of the dashboard page. Sort the "Order Type" column to find all of the donation orders.

Troops Can Now Manage Recognition Orders Using Smart Cookies

Damages

If your troop picks up cookies at the Albuquerque cupboard, the packages need to be returned to the cupboard and you may opt to have the packages replaced or removed from your inventory. Outside of the Albuquerque area, we will remove the package from your inventory.

Digital Cookie Reminders

Families selecting rewards in Digital Cookie

<u>Remind Families to Approve Girl Delivery Orders and Contact Customers</u> <u>with Delivery Information</u>

Girl Scout caregivers have 5 days to approve Girl Delivery orders. If not, the order will be cancelled or changed to a Hometown Hero donation. Also, families should be contacting customers once orders are approved with expected delivery information.

Creating a Recognition order – Early, Troop and Main

Once the order has generated, open any line with a red triangle symbol to make recognition choices or size selections. Click on the extrastab. Most extra items generate automatically, but there may be manual selections. Repeat for each girl. When finished save order and go to Rewards>Manage Orders. Confirm your order is COMPLETE.
