Smart Cookie Reminders

Deleting Smart Cookies Transfers.

Troop Cookie Chairs may now delete transfer orders that were initiated by their troop. To delete a Troop to Girl, Girl to Troop, Girl to Girl or Troop to Troop transfer, scroll all the way to the far left of the transaction line and select the three vertical blue dots for the Delete Order button.

Damages

If your troop discovers packages that are too damaged to sell or a case that is missing a package, please take pictures and send the pictures to <u>customercare@nmgirlscouts.org</u>. If your troop picks up cookies at the Albuquerque cupboard, the packages need to be returned to the cupboard and you may opt to have the packages replaced or removed from your inventory. Outside of the Albuquerque area, we will remove the package from your inventory. **All damaged packages must be reported to council by Sunday**, **March 24**th.

Digital Cookie Reminders

Families selecting rewards in Digital Cookie

If your families say they can't select rewards, please check your troop dashboard. There is a Troop Rewards section. Please make sure the end date is listed as 03/24/2024 at the latest. If you have already established a deadline for your families to make selections, you may set the date to that deadline. *If your troop participated last year, your date might be listed for 2023 instead of 2024.*

<u>Remind Families to Approve Girl Delivery Orders and Contact Customers</u> <u>with Delivery Information</u>

Please follow up with Girl Scout families who still have orders that are not listed as delivered in Smart Cookies. **All orders should be approved by Thursday, March 21**st **and marked as delivered by Sunday, March 24**th. Any orders that are not delivered by that time need to be refunded to the customer. Troop chairs can issue refunds for girl delivery orders. Greetings Girl Scout Family,

Thank you for participating in the 2024 Girl Scout Cookie Program. Your troop's Cookie Chair Volunteer has been hard at work making sure your Girl Scout has a positive and fulfilling experience. With the new bakery, we had many changes behind the scenes. One of the biggest changes has been the way our software tracks and credits donated cookie sales for Girl Scouts. These donated cookies are called Cookie Shares and are the donated cookies for the Hometown Heroes program.

We are reaching out because you may have been notified that your Girl Scout's balance due changed when the volunteer accounted for your Girl Scout's donation sales. This is not due to an error on the volunteer's part, nor are you being asked to pay for cookies your Girl Scout did not sell. This is not an error with the system as well. This is accounting for all the cookies packages sold.

While you may have not taken the physical donation packages, your Girl Scout has sold these donation packages. Just like when a customer purchases cookies for direct shipping. You do not handle those packages, but they are still credited to your Girl Scout, the payment is still added to the balance summary. What was happening was that payment was credited to your account at the time of purchase, but the cookies were not. As the credit for the packages is being added, the amount due will change.

Checklist for Closing the Cookie Program

1. Check the Transfers section in Smart Cookies: Make sure all transactions from Troop to Troop transfers and cupboard pick-ups are correct. If there are any issues with Troop to Troop transfers, please reach out to the troop who gave away product to edit the transaction in Smart Cookies. If there are any issues with cupboard transactions, please email productprogram@nmgirlscouts.org



2. Make sure all cookies are distributed in Smart Cookies.

□ Make sure all troop link cookies are distributed to Girl Scouts needing a boost for rewards. You can do this under the Orders Tab Troop Direct Ship Orders section. See example on next page

□ Make sure all Cookie Donations from Digital Cookie have been entered into Smart Cookie this includes "Donation," In-Person Delivery with Donation," and "Cookies In Hand with Donation." Check out the video in gsLearn for more information.

□ If you have any unsold cookies, you can use the inventory to cover your Cookie Share orders using the "Tracked Cookie Share" feature and assigning the cookies to the Girl Scout like a normal "Troop to Girl" transfer. Check out the video in gsLearn for more information.

□ Run the Troop On Hand Inventory Report and make sure the total line is 0 – even if cookies are unsold. See report example on next page.

□ If your Troop On Hand Inventory Report is negative, this means you over allocated cookies. Please double check all your Troop to Troop Transactions and Cupboard Transactions are correct. Also run the Girl Cookie Order Detail Summary report to check each transfer to a Girl Scout. See report example on next page. *If your Troop On Hand Inventory Report is not zero the council office will follow–up with you.*

□ Use the spreadsheet (example above) to see which Girl Scouts have submitted their rewards. It will show the reward selected and size if needed. Also, it will have the words **Not Selected** if the family did not select a reward so you can follow-up with the family.

□ The rewards will NOT transfer into Smart Cookies, so you will have to make the selections.

□ Log into Smart Cookies to submit your troop's rewards.

□ If you have a Girl Scout who would like to select one of the **Opt Out rewards.** Select an opt out plan for that Girl Scout. Go to the "My Troop" tab in Smart Cookies. Select the "Troop Roster" link. For the Girl Scouts that wants to opt out, click on the blue pencil on the far left. In the "Main Recognitions Plan" drop down, select the desired opt out plan and then hit save.
